**(FOR PROVISIONALLY ADMITTED APPLICANTS ONLY)**

**Date: 23.07.2022**

**Please go through the following instructions very carefully:**

1. All the **candidates admitted provisionally** are instructed to submit their X Board marks and upload self-attested X Board mark-sheet online by 4:30 PM today(23-07-2022). A link has already been provided on our website on the day of declaration of CBSE X Board Result.
2. **Final admission process will be finished within 4 days of the declaration of Class-X CBSE Board Result.** You are instructed to take admission within the specified date range. No claim will be entertained after 26-07-2022.
3. After the submission of X Board marks and uploading X Board mark-sheet, a link will be provided to pay the balance amount for final admission to all eligible applicants as per our admission eligibility criteria which is given below in Point 4. Balance amount must be paid between 24-07-2022 and 26-07-2022. If not paid within the given date range then candidature for final admission will be treated as cancelled and fee paid for Provisional admission will not be refunded. Candidates can pay the balance amount by entering the Reference Id in the link that will be provided after 8.00 AM on 24-07-2022.

**4. Admission Eligibility Criteria:**

<b>Stream</b>	<b>Minimum marks(%) in CBSE/Other Boards</b>
Science	80%
Commerce	65%
Arts	60%

5. In case of non-fulfilment of the Admission Eligibility Criteria after the declaration of the Class-X Board Result, the provisional admission will stand cancelled and the amount of Rs. 40,000/- (Rupees Forty Thousand only) deposited for Provisional Admission will be refunded (Refund process for Non Eligible Provisionally Selected candidates will be made available on school's website on 27.07.2022).
6. **In case of fulfilment of the Admission Eligibility Criteria and/or non-submission of X Board marks on our School Website, request for withdrawal of admission will not be entertained and no amount will be refunded.**
7. Limited seats are available in the School buses and not all students may be accommodated. The applicants who could not secure a seat in the bus will have to make their own arrangements. A Link for opting School Bus Facility for the newly admitted students will be made available on our School Website after 5.00 PM on 23-07-2022. Kindly note that submission of request will be on first-cum-first-serve basis as seats are limited. The Link will be closed automatically as soon as the available seats are filled. Bus facility once sanctioned by School on your request will not be considered for cancellation for full Academic session.
8. Induction Program for newly admitted students (who have paid balance amount and taken final admission) will be held on 30.07.2022 at 1:00 pm.  
Venue: Swami Tapovan Hall, Chinmaya Vidyalaya, Bokaro. Students must come in School Uniform (Get uniform details from link scrolling on the home page of School website). Get your School Admission number and Section from the link that will be provided on School website on 28.07.2022 after 5:00 pm upon entering Reference ID.
9. **Classes will commence from 01.08.2022 (Timetable will be made available after the Induction program through our Vidyalaya Website)**

10. **In case of any wrong/incorrect information, admission will be cancelled and legal action will be initiated. Also, in this case no amount will be refunded.**
